Report on the Financial Report

We have audited the accompanying financial report, being a special purpose financial report, of The Operation Restore Hope Philippines Relief Fund (the trust), which comprises the balance sheet as at 30 June 2008, and the income statement, a summary of significant accounting policies and other explanatory notes and the directors of Operation Restore Hope Australia Limited's (the trustees') declaration.

Trustees' Responsibility for the Financial Report

The trustees of the trust are responsible for the preparation and fair presentation of the financial report in accordance with Australian Accounting Standards (including the Australian Accounting Interpretations) and the trust deed.
